The Chickasaw City Council met in regular session on Tuesday, July 26, 2016 at 7:00 PM with the following members present: Mickey Day, Henry Phillips, Adam Bourne, Jennifer White, Eloise Clubbs and Mayor Byron Pittman who presided. Attorney Joe Aguirre and City Clerk Rachael Stubbs were also present. Mr. Bourne opened the meeting with prayer.

Mr. Phillips made a motion seconded by Mrs. Clubbs to approve the minutes of the July 12, 2016 meeting and conference as previously distributed. Motion carried and so ordered.

**CORRESPONDENCE**

A resignation was presented for Tywone Johnson, Public Safety Officer. Mr. Phillips made a motion seconded by Mr. Bourne to accept the resignation "in good standing." Motion carried and so ordered.

First Quarter Working Test Report was presented for Janice Starling, Fiscal Clerk II, which the Department Head stated that she was continuing to investigate and observe the merit, efficiency, fitness, and moral responsibility of the employee named above, and had made no decision to recommend acceptance or dismissal of this employee. Mr. Bourne made a motion seconded by Mrs. Clubbs and Mr. Phillips to accept the Department Head's recommendation. Mr. Day voted, "no". Motion carried and so ordered.
