The Chickasaw City Council met in regular session on Tuesday, June 9, 2015 at 7:00 PM with the following members present: Mickey Day, Henry Phillips, Jennifer White, Adam Bourne, Eloise Clubbs, and Mayor Byron Pittman, who presided. City Attorney Jay Minus, Fiscal Clerk Jessica Veals and City Clerk Rachael Stubbs were also present. Mr. Bourne opened the meeting with prayer.

Mr. Phillips made a motion seconded by Mrs. Clubbs to approve the minutes of the May 26, 2015 meeting and conference as previously distributed. Motion carried and so ordered.

**PUBLIC HEARINGS**

A public hearing was held concerning the property at 11 Gulf St., which is owned by Orella M. Peterson. No one was present on behalf of the property. Mr. Craig said that the letters he had sent had been returned. He provided photos to the Mayor and Council to review. Mr. Bourne made a motion seconded by Miss White to conclude the public hearing. There were no objections. Motion carried and so ordered. Mr. Phillips made a motion seconded by Mr. Bourne to declare the property a public nuisance. Motion carried and Resolution 2015-09 was adopted.

**CORRESPONDENCE**

Second Quarter Working Test Report was presented for Steven Hughes, Fire Service Captain, which the Department Head stated that he was continuing to investigate and observe the merit, efficiency, fitness, and moral responsibility of the employee named above, and had made no decision to recommend acceptance or dismissal of this employee. Mr. Phillips made a motion seconded by Mrs. Clubbs to accept the Department Head's recommendation. Motion carried and so ordered.

Mr. Bourne made a motion seconded by Miss White to authorize payment of an invoice to Roto Rooter for repairs made to a sewer line and storm drain at 188 Baratara in the amount of \$2,200. Motion carried and so ordered.

Mr. Bourne made a motion seconded by Mr. Phillips to authorize payment of an invoice in the amount of \$17,400 to Betancourt and King for audit services. Motion carried and so ordered.

Mr. Bourne made a motion seconded by Miss White to authorize repairs to City's Trash Grapper Truck in the amount of \$6,920.89. Motion carried and so ordered.

**Mayor's Report:** Mayor Pittman stated that with the end of the school year that the Recreation Donation and Coach's Playoff Bonus Program should be reviewed. Mrs. Clubbs made a motion seconded by Mr. Bourne to suspend both the Recreation Donation and Coach's Playoff Bonus until further notice. Motion carried and so ordered.
