The Chickasaw City Council met in regular session on Tuesday, March 22, 2016 at 7:00 PM with the following members present: Mickey Day, Henry Phillips, Adam Bourne, Jennifer White, Eloise Clubbs and Mayor Byron Pittman who presided. City Attorney Jay Minus and City Clerk Rachael Stubbs were also present. Dr. Adam Hammond from First Baptist Church Chickasaw opened the meeting with prayer.

Mrs. Clubbs made a motion seconded by Mr. Bourne to approve the minutes of the March 8, 2016 meeting and conference as previously distributed. Motion carried and so ordered.

**CORRESPONDENCE**

Second Quarter Working Test Report was presented for Dennis Sullivan, Public Service Supervisor II, which the Department Head stated that he was continuing to investigate and observe the merit, efficiency, fitness, and moral responsibility of the employee named above, and had made no decision to recommend acceptance or dismissal of this employee. Mr. Bourne made a motion seconded by Mrs. Clubbs and Mr. Phillips to authorize Mayor Pittman to sign the Annual MS4 report. Motion carried and so ordered.

**Mayor's Report:** Mayor Pittman presented the Zoning Regulations Ordinance previously approved for a first reading at the last City Council meeting. Mr. Bourne made a motion seconded by Miss White to approve the Ordinance. Motion carried and Ordinance 2016-03 was adopted.
