The Chickasaw City Council met in regular session on Tuesday, May 10, 2016 at 7:00 PM with the following members present: Mickey Day, Henry Phillips, Adam Bourne, Jennifer White, Eloise Clubbs and Mayor Byron Pittman who presided. City Attorney Jay Minus and City Clerk Rachael Stubbs were also present. Mr. Bourne opened the meeting with prayer.

Mrs. Clubbs made a motion seconded by Mr. Phillips to approve the minutes of the April 26, 2016 meeting and conference as previously distributed. Motion carried and so ordered.

**PUBLIC HEARINGS**

A public hearing was held concerning the proposed addition to the Zoning Regulations Ordinance to include a section on Political Signs. No one had any comments. The hearing concluded at 7:05 PM. Mr. Phillips made a motion seconded by Mrs. Clubbs to suspend review of the Ordinance for 90 days. Mayor Pittman, Mr. Day, Mr. Bourne and Miss White voted, "No". Motion failed. Mr. Bourne made a motion seconded by Miss White to present the Zoning Ordinance amendment for first reading. Mr. Phillips voted, "No". Motion carried and so ordered.

**CORRESPONDENCE**

Third Quarter Working Test Report was presented for Jarret Lowe, Public Safety Officer, which the Department Head stated that he was continuing to investigate and observe the merit, efficiency, fitness, and moral responsibility of the employee named above, and had made no decision to recommend acceptance or dismissal of this employee. Mr. Phillips made a motion seconded by Mr. Bourne to accept the Department Head's recommendation. Motion carried and so ordered.

**Mayor's Report:** Mayor Pittman presented an agreement with C-Spire to continue providing the City of Chickasaw's phone service. Mr. Phillips made a motion seconded by Mrs. Clubbs to authorize Mayor Pittman to sign the agreement. Motion carried and so ordered.

Mayor Pittman presented an agreement with Comcast to provide internet and two analog phone lines at the Library. Miss White made a motion seconded by Mr. Bourne to authorize Mayor Pittman to sign the agreement. Motion carried and so ordered.

Mayor Pittman presented a contract for performer Cary Laine to provide entertainment at the 4<sup>th</sup> of July celebration. Mr. Phillips made a motion seconded by Mr. Bourne to authorize Mayor Pittman to sign the agreement. Motion carried and so ordered.

Mayor Pittman stated that since he was running for Mayor that he would be appointing Rachael Stubbs to perform his election duties so there would not be a conflict of interest. Mr. Phillips made a motion seconded by Mrs. Clubbs to appoint Rachael Stubbs as the election official to perform Mayor Pittman's duties. Motion carried and Resolution 2016-06 was adopted.

Mayor Pittman stated that Nell Barnes had resigned from the Industrial Development Board. He asked for any recommendations for a good replacement for spot.
