The Chickasaw City Council met in regular session, via Zoom video conference call, on Tuesday, June 09, 2020 at 7:00 PM with the following members present: Barry Broadhead, Derrick Jones, Adam Bourne, Jennifer White, James Hanson and Mayor Byron Pittman who presided. City Clerk Jessica Veals and Attorney Jay Minus were also present. A reporter from the Call News was also present. Mr. Jones opened the meeting with prayer.

Mr. Broadhead made a motion seconded by Mr. Hanson to approve the minutes of the May 26, 2020 work session meeting minutes as previously distributed. Motion carried and so ordered.

CORRESPONDENCE

A resignation for Public Safety Officer, Joseph Lynch, was presented to the council. Mr. Hanson made a motion seconded by Mr. Broadhead to approve this resignation in “good standing”. Motion carried and so ordered.

REPORTS

Attorney’s Report: Mr. Minus had nothing to present.

Code Inspector’s Report: Building Inspector, Chuck Janes, gave the May 2020 report.

Chief’s Report: Public Safety Chief, Brian Filligim, gave the May 2020 report.

COUNCIL COMMITTEE REPORTS

Parks and Recreation: Miss White made a motion seconded by Mr. Broadhead to allow Mayor Pittman to enter into contract with Kimley Horn for any engineering services the city will need in the future. Motion carried and so ordered.

Finance: Mr. Bourne made a motion seconded by Mr. Hanson to place the accounts payable in the amount of \$23,541.85 in line for payment. Motion carried and so ordered.

Public Service: Mr. Hanson had nothing to vote on.

Maintenance and Sanitation: Mr. Broadhead made a motion seconded by Mr. Bourne to allow Dennis Sullivan to purchase paint to repaint the letters on the Chickasaw Fire Station at a cost not to exceed \$1000.00. Motion carried and so ordered.

Public Safety: Mr. Jones had nothing to vote on.

Mayor's Report: Mayor Pittman updated the council on a meeting with True North Emergency Management Services to help the city apply for State and Federal Covid-19 Emergency Funds.

Mayor Pittman presented the council with a quote from Hammco Tree Service to cut down four trees located at the Chickasaw Pool. The council voted unanimously to approve Hammoc Tree Service to cut down the trees. Motion carried and so ordered.

Mayor Pittman was presented with a quote to replace the lights at the Chickasaw Library. Mayor Pittman requested that Dennis Sullivan get two additional quotes on how much the project would cost.

Mayor Pittman asked the council their recommendation on campaigning during the July 4th celebration. The council unanimously voted to approve no campaigning during the July 4th celebration. Motion carried and so orderd.
