2. That **Ken Sterrett** received a majority of the votes cast for the office of **Councilmember Place No. 2** and is hereby declared duly elected to that office for a term beginning on the first Tuesday in November, 2020.
3. That **Jason Rawls** received a majority of the votes cast for the office of **Councilmember Place No. 2** and is hereby declared duly elected to that office for a term beginning on the first Tuesday in November, 2020.
4. That **Jennifer White** received a majority of the votes cast for the office of **Councilmember Place No. 3** and is hereby declared duly elected to that office for a term beginning on the first Tuesday in November, 2020.
5. That **Adam Bourne** received a majority of the votes cast for the office of **Councilmember Place No. 4** and is hereby declared duly elected to that office for a term beginning on the first Tuesday in November, 2020.
6. That **James “Jim” Hanson** was unopposed for the office of **Councilmember Place No. 5** and is hereby declared duly elected to that office for a term beginning on the first Tuesday in November, 2020
