The Chickasaw City Council met in regular session, via Zoom video conference call, on Tuesday, November 10, 2020 at 7:00 PM with the following members present: Ken Sterrett, Jason Rawls, Adam Bourne, James Hanson, Jennifer White and Mayor Barry Broadhead who presided. City Clerk Jessica Veals and Attorney Nash Campbell were also present. Mr. Rawls opened the meeting with prayer.

**APPROVAL OF MINUTES**

Miss White made a motion seconded by Mr. Bourne to approve the minutes of the October 13, 2020 regular scheduled meeting minutes as previously distributed. Motion carried and so ordered.
