

**APRIL 27, 2021**

The Chickasaw City Council met in regular session on Tuesday, April 27, 2021 at 7:00 PM with the following members present: Jason Rawls, Ken Sterrett, James Hanson, Jennifer White, Adam Bourne and Mayor Barry Broadhead who presided. City Clerk Jessica Veals and City Attorney Nash Campbell were also present. Mr. Hanson opened the meeting with prayer.

**ADOPTION OF AGENDA**

Miss White made a motion seconded by Mr. Bourne and Mr. Rawls to approve the agenda for the regular scheduled council meeting on April 27, 2021. Motion carried and so ordered.

**APPROVAL OF MINUTES**

Mr. Bourne made a motion seconded by Mr. Rawls to approve the minutes of the April 13, 2021 regular scheduled meeting minutes as previously distributed. Motion carried and so ordered.

**COMMUNICATIONS FROM THE MAYOR**

Mayor Broadhead stated that the Fire Department needed to add emergency lights to the Jeep Liberty to use for medical emergencies only. Mr. Hanson and Mr. Rawls made a motion seconded by Mr. Sterrett to approve to have the Jeep Liberty outfitted with emergency lights at a cost not to exceed \$3,000.00. Motion carried and so ordered.

Mayor Broadhead presented a quote from L & L Saw to the council for a new lawn mower for the maintenance department. Miss White made a motion seconded by Mr. Bourne to approve the purchase of a new lawn mower from L & L Saw at a cost not to exceed \$7,000.00. Motion carried and not ordered.

Mayor Broadhead presented the council with a new Animal Control Ordinance 2021-10. Mr. Hanson made a motion seconded by Mr. Rawls to suspend the rules and adopt Animal Control Ordinance 2021-10 immediately, and effective July 1, 2021. Roll call vote went as follows: Kendall Sterrett, "Yes"; Jason Rawls, "Yes"; Barry Broadhead, "Yes"; Jennifer White, "Yes"; Adam Bourne, "Yes"; James Hanson, "Yes". Motion carried and so ordered.

Mayor Broadhead presented the council with a quote from Mobile County for four used maintenance vehicles in the amount of \$5,100.00. Miss White made a motion seconded by Mr. Rawls to approve the purchase of four used maintenance vehicles. Motion carried and so ordered.

Mayor Broadhead stated that the city had a proposal from a resident to purchase two lots, located on one parcel, from the city. Mr. Hanson made a motion seconded by Mr. Sterrett to sell the

property for fair market value. Motion carried and so ordered.

Mayor Broadhead presented the council with a proposal from Kimley Horn for Brooks Park from a grant that the city was selected for. Miss White made a motion seconded by Mr. Bourne to accept the proposal from Kimley Horn for improvements for Brooks Park. Motion carried and so ordered.

Mayor Broadhead presented the council with Storm Water Ordinance 2021-11. Mr. Bourne made a motion seconded by Mr. Rawls to suspend the rules and adopt Storm Water Ordinance 2021-11 immediately. Roll call vote went as follows: Kendall Sterrett, "Yes"; Jason Rawls, "Yes"; Barry Broadhead, "Yes"; Jennifer White, "Yes"; Adam Bourne, "Yes"; James Hanson, "Yes". Motion carried and so ordered.

Mayor Broadhead presented the council a quote from Sunbelt Fire in the amount of \$10,917.00 to install equipment on the new city fire truck. Mr. Bourne made a motion seconded by Mr. Rawls to authorize Sunbelt Fire to install equipment on the new city fire truck at a cost not to exceed \$11,000.00. Motion carried and so ordered.

There were no appeals presented at this time.

### **PRESENTATION OF PETITIONS AND OTHER COMMUNICATIONS TO THE COUNCIL**

There were no petitions or other communications for the council at this time.
