The Chickasaw City Council met in a regular session on Tuesday, April 25, 2023, at 7:00 PM. Present were Councilmembers: Jim Hanson, Jason Rawls, Ken Sterrett, and Jennifer White. City Attorney Nash Campbell and City Clerk Michelle Ross. Councilmember Bourne was absent. There being a quorum present, Mayor Broadhead called the meeting to order. Councilmember Hanson gave the invocation and ledge the Pledge of Allegiance.

ADOPTION OF AGENDA

Councilmember White moved to approve the agenda for the regularly scheduled meeting on April 25, 2023. Councilmember Rawls seconded the motion. Motion carried, and so ordered.

APPROVAL OF MINUTES

Councilmember Hanson made a motion, seconded by Councilmember White, to approve the minutes of April 11, 2023. Councilmember Rawls abstained as he was in attendance. Motion carried, and so ordered.

Councilmember White made a Motion to approve the Volkert Bridge inspection for 2023/2024, not to exceed \$30,000. Councilmember Rawls seconded the motion. 2. Re-Appointment to City of Chickasaw School Board – Councilmember Sterrett made a motion to reappoint Jenny Parker to the City of Chickasaw School Board – 5-year term. Councilmember Hanson seconded the motion. Motion for final adoption passed by the following voice votes: AYE – White, Rawls, Hanson, Sterrett. NAY-None.

Councilmember Hanson moved to adopt Resolution No. 23-10 - Authorizing a Lump Sum Salary Supplement for the City of Chickasaw Full-Time Employees that have been employed by the City for one year. Effective May 1, 2023. Total amount not to exceed \$100,000. \$1,500 to be given in 2023 and \$1,500 to be given in 2024. Total of \$3,000 per eligible employee. The source of the funding is the American Rescue Act. Seconded by Councilmember Sterrett and Councilmember Rawls. Motion for final adoption AYE –White, Rawls, Hanson, Sterrett, NAY-None

Accounts Payable \$48,957.85


