Craft Hwy.) to Parker Ln., along Parker Ln. from Jefferson St. to Sutherland Dr., along Sutherland Dr. between Parker Ln. and SR-13 (US-43/N. Craft Hwy), and along SR-13 (US-43/N. Craft Hwy.) from Myrtlewood Ave. to 1st St.; Project #TAPMB-100078286 and 100078288.

WHEREAS, the total preliminary engineering cost is estimated at \$40,569.78; City of Chickasaw is responsible for 20% (\$8,113.96); Federal TAPMB funds \$32,455.82.

WHEREAS, the total construction cost is estimated to be \$459,249.85; City of Chickasaw is responsible for 20% (\$91,849.97); Federal TAPMB funds \$367,399.88.
