A RESOLUTION AUTHORIZING THE SUBMISSION OF FISCAL YEAR 2025 HOMELAND SECURITY FUND GRANTS
TO ADECA FOR FIRST RESPONDERS' EQUIPMENT

WHEREAS, the City of Chickasaw needs to purchase new law enforcement and firefighter equipment to be utilized by the Police Department and the Fire Department; and

WHEREAS, the Law Enforcement and Traffic Safety Division of the Alabama Department of Economic and Community Affairs has funding available through the Fiscal Year 2025 Homeland Security Grant Funds to purchase first responder equipment; and

WHEREAS, the Police Department is in need of two mobile security trailers that cost a total of \$76,878, and the Fire Department is in need of thermal imagers, gas monitoring equipment, and turnout gear for a total cost of \$96,703;

NOW, THEREFORE BE IT RESOLVED, that the Mayor and City Council authorize submission of the grant applications to ADECA requesting a total of \$173,581 in FY Homeland Security Grant Funds (\$76,878 from the law enforcement fund and \$96,703 from the Fire Operations Fund) by the deadline of May 15, 2025; and

BE IT FURTHER RESOLVED, that the Mayor is authorized to sign the grant-related documents.

AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES FOR THE FY2025 REBUILD ALABAMA ACT (RAA) RRR PROJECT TASK 002

WHEREAS, the City of Chickasaw was awarded a FY25 Rebuild Alabama Act (RAA) RRR Project Task Order 002 Grant from the Alabama Department of Transportation for \$250,000.

WHEREAS, Kimley-Horn has experience and expertise in the foregoing, and understands the project will consist of resurfacing Grant Street, Short Street, Ryan Street, and 12th Avenue.

WHEREAS, the City desires to retain Kimley-Horn for professional engineering services for the FY25 Rebuild Alabama Act (RAA) RRR Project Task 002.

WHEREAS, Kimely-Horn will perform the services in Task 1- Design and Task 2 - Limited Construction Observation for a total lump sum of \$40,000.00.

RESOLUTION TO APPROVE CHANGE ORDER #3 AND EXPEND FUNDS FROM THE CITY OF CHICKASAW CAPITAL IMPROVEMENTS ACCOUNT TO REPAIR EXTERIOR ROTTEN WOOD AT THE CIVIC CENTER

WHEREAS, the City of Chickasaw Civic Center, a critical public facility, requires urgent repairs due to the deterioration of wood structures that have rotted and pose a risk to the building's structural integrity; and

WHEREAS, the repair of the rotten wood is essential to maintain the safety, function, and aesthetic value of the Civic Center, ensuring continued service to the community; and

WHEREAS, the funds are available in the Capital Improvement Fund to address this unanticipated expenditure;

WHEREAS, the Public Works Department has assessed the damage and determined that repairing the rotten wood in the Civic Center is necessary and appropriate to ensure the building's long-term viability;

NOW, THEREFORE BE IT RESOLVED, that the City of Chickasaw Council approves the expenditure of funds from the Capital Improvement Account to complete the repair of rotten wood in the Civic Center, as recommended by the Public Works Department; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City of Chickasaw Council approves the expenditure of funds from the Capital Improvements Account in the amount of \$28,368.42 to repair the exterior rotten wood as per Armstrong & Associates Changer Order #3

BE IT FURTHER RESOLVED, that the disbursement of funds shall be made by the policies and procedures of the City of Chickasaw and any applicable laws and regulations.

BE IT FURTHER RESOLVED, that the City Clerk will take any further action necessary to implement this resolution.
